PUBLIC COMMENT

• Dan Baney family was present to voice their concerns about safety at Route 97/Flatts Road. They had contacted DOT who advised them they needed a letter form the Township requesting a traffic study.

Motion was made by Kondzielski, seconded by Malinowski, to write to PaDOT requesting a traffic study at the intersection of Route 97/Flatts Road. Vote: 2/0

• Cindy Kreider asked if supervisors had a chance to discuss plantings in the round-a-bout. Kondzielski suggested a flagpole with short plants. Brief discussion ensued.

- Truck 10 needs a set of tires; it is the only one that did not get tires last year. Brian will get prices.
- Brian talked to Andrew and Steve Halmi about the Barton Road project, and about the stormwater project behind the Township buildings.

NEW BUSINESS

- Waterford Fair Board has requested Township assistance in grading the roads within the fairgrounds before the fair, and in removal of manure after the fair ends. Motion was made by Kondzielski, seconded by Malinowski, to take care of the fair ground roads, which we do every year, and supply two trucks to move the manure up the hill. Vote: 2/0
- Supervisor Senger request to change Local Services Tax to \$52: Chairman indicated that the Borough is currently at \$52 per person employed in Waterford Borough, and Senger would like the Township to do that also, and direct those funds to the fire department. We would need to find out what the steps are that we must take to do this.
- Supervisor Senger would like to give the fire department an additional \$40,000. Kondzielski does not mind doing this but he would like to know where it is going. No action was taken at this time, for further research.
- Motion was made by Malinowski, seconded by Kondzielski, to purchase eight (8) tires for Truck #10, at the lowest price. Vote: 2/0
- Brief discussion opened on the incorporation of Waterford Township.
