RESOLUTION NO. 11-2019

A RESOLUTION OF THE BOARD OF SUPERVISORS OF SADSBUURY TOWNSHIP, LANCASTER COUNTY, PENNSYLVANIA, SETTING THE COMPENSATION FOR THE OFFICE OF ELECTED TAX COLLECTOR IN THE TOWNSHIP OF SADSBUURY.

WHEREAS, this Township has reviewed the costs of collection of real estate taxes and has obtained information concerning costs and payments of other Lancaster County municipalities, including the County of Lancaster; and

WHEREAS, numerous Lancaster County municipalities have established \$0.75 per bill as the compensation to be paid to collect real estate taxes; and

WHEREAS, the County of Lancaster imposes and collects a fee of \$5.00 for tax certifications, which fee appears to be fair and reasonable; and

WHEREAS, this Township desires to establish compensation for the position of Tax Collector based on its review of costs and fees paid by other Lancaster County municipalities and the County of Lancaster.

NOW, THEREFORE, BE AND IT IS HEREBY RESOLVED by the Board of Supervisors of the Township of Sadsbury, Lancaster County, Pennsylvania, as follows:

Section 1. Beginning January 1, 2020, the compensation for any person elected to or appointed to the office of elected tax collector in the Township of Sadsbury taking office after January 1, 2020, shall be seventy-five cents (\$0.75) per tax bill; provided, however, that in no event shall the compensation of the tax collector exceed five (5%) percent of the amount of each tax bill collected.

Section 2. The Township real estate tax notice and all other bills which may be included with the real estate tax notice, including but not limited to any street light tax notice, shall constitute one tax bill for the purpose of determining the compensation payable to the tax collector hereunder and shall not be considered separate tax bills.

Section 3. The Township shall provide postage to the tax collector for the mailing of tax bills as required by the Local Tax Collection Law.

Section 4. The Board of Supervisors hereby imposes the following fees for services provided by the Tax Collector which are not part of the Tax Collector's required duties under the Local Tax Collection Law:

Issuing of tax certification	\$5.00
Issuing of duplicate bills, receipts, or similar records	\$5.00

Section 5. The Board of Supervisors hereby appoints the elected Tax Collector as the municipal officer authorized to provide tax certifications and administrative services relating to the collection of real estate taxes upon request by the public.

Section 6. All fees established in accordance with Section 4 of this Resolution shall be assessed, collected, and retained by the Tax Collector.


Section 7. In the event any provision, section, sentence, clause or part of this Resolution shall be held to be invalid, illegal or unconstitutional by a court of competent jurisdiction, such invalidity, illegality or unconstitutionality shall not affect or impair the remaining provisions, sections, sentences, clauses or parts of this Resolution, it being the intent of the Board of Supervisors that the remainder of the Resolution shall be and shall remain in full force and effect.

Section 8. This Resolution shall take effect and be in force immediately.
